CASA DA CALÇADA

The protection of your privacy is seen as a priority by Casa da Calçada. Thus, we detail clearly below, how we use the information collected through our official website.

What information is collected by Casa da Calçada?

Personal Information

Casa da Calçada only collects information that is voluntarily given by visitors to our website. This is granted when, for example, they fill out a form or subscribe to the official newsletter. The data being collected may differ according to the specific situation. However, the user's name, email address, address and telephone number are often restricted, among other details.

Other Information

Casa da Calçada collects anonymous information when users visit the website. This information can include the type of device, operating system and browsers used to access the site, geographic location, duration of visit and number of pages visited. It is not possible to relate these elements to individual users.

What does Casa da Calçada do with the collected information?

All information collected by Casa da Calçada is used exclusively by the organization.

Casa da Calçada ensures the security and privacy of its users' data, committing itself not to sell, exchange, rent or share it to third parties without their consent. As an exception there is the request for an obligatory court decision.



The information collected is organized internally in a database and can be used to:

- Improve our services and products;
- Improve the customer support service;
- Send periodic information that may be of interest to users;
- Improve the contents of our website

COOKIES

What are cookies?

A "cookie" is a small amount of text sent to your browser by a website you visit. It helps the page to remember information about your visit and settings, so that the next visit can be easier and more useful for you.

Cookies have two types:

- **Session cookies** – They are temporary, remain in the user's browser until he leaves the Website and allow Casa da Calçada to obtain statistical information about the users' behavior during the visit.
- **Permanent cookies** - They are stored in the user's browser until they are deleted or their term expires and are used whenever he makes a new visit to the Website to recognize the user.

Casa da Calçada uses cookies for different purposes:

- **Analytical cookies:** These cookies collect anonymous statistical information that helps Casa da Calçada to understand the way our visitors interact with the page. You can use cookies to collect and report information, collecting non-personalized statistical data, not personally identifying any visitors. This means that we can identify what works best to improve the page;
- **Functional cookies:** We use these cookies to remember your preferences and to help you navigate the page;
- **Advertising cookies:** These are used to measure the effectiveness of our advertising and help us to make decisions about how to optimize it according to users' preferences and behaviors.

TRACKING PIXEL

They are small lines of computer code that collect information about visitors and are used for Casa da Calçada to know how users navigate the website, what links and pages they upload, and what type of ad they click on.

All newsletters sent by Casa da Calçada also contain a link that gives the user the option to stop receiving our newsletter.
